- **II.** <u>MINUTES:</u> E. Benson made a motion to accept the minutes from the September 11, 2017 board meeting, H. Russell seconded, the motion was passed and carried.
- III. <u>WRITTEN & VERBAL REPORTS</u>: See attached written reports.
 - FSA- The few NASS surveys that were filled out allowed for a corn loss payment coming through for \$60. It is important to fill them out because potential payments for loss are contingent upon these received reports.

NRCS- A Soil Conservation has been hired to fill the vacant position in Walton.

- A. Neversink/Rondout Grant: See written report

 - Planting trees and willows on several project sites.
 - Claryville project plans almost 100% complete. Looking to bid project soon.

- SCA Intern will work January 22 November 16, 2018. Will need to wait until spring to see if we will get a 5-month intern. These positions are funded through the SCA.
- Town of Denning project is progressing slowly due to the engineering work is being held up. The Town may start looking for other avenues of funding.
- B. Program Updates:
 - Flood Mitigation Waiting for invoices from the Towns of Callicoon, Fremont and Tusten for completed projects.
 - The NYSSWCC approved using Part C funds to purchase new truck. Robert Green Chevrolet was low bidder. A Dodge Ram was ordered, and we are awaiting arrival.
 - FOIL Policy was reviewed by County Attorney and minor word changes were made.
- C. Insurance Bids: Bid request will be re-sent out in January as no bids were received due to underwriters will only write a quote a few months from the policy renewal date.

- A. Bank Reconciliation: The September and October bank statements were reviewed.
- B. County Budget: Still waiting on status of 2018 District Budget funding. Will contact county for information.
