- T. Capraro (NRCS):
 - Regional Conservation Partnership (RCP) Program was announced. This program is for Forestry conservation and it is administered under and subject to EQIP regulations. This program is a voluntary sign up but projects are ranked. A copy of sign-up paperwork will be left at the office for applicants.
 - Total of ten (10) EQIP applications for Sullivan Residents were submitted with five (5) applicants were eligible and have received approval for funding.

A. Neversink/Rondout Grant: See written report

- Finishing up the Claryville flood analysis with Barton & Loguidice. Should receive final draft and intend to present to Town Committee in two weeks and then present to Town Board in April. This is the end of the process for Claryville.
- Beginning the work for the Sundown flood analysis, Town of Denning, in Ulster County.
- Planning projects for Claryville. Have three sites picked out in the Town of Denning. Sent out four RFPs for survey work and only two responded. Presented two Survey contracts for Willies signature, Brooks & Brooks Surveying and Catskill Region Surveying Services.
- Working on planning the projects this year and implement them next year.
- A RFP for engineering work was sent out to five firms and two responded and are being reviewed. Chose to work with both firms, Barton and Loguidice and Louis Berger. Should have the two contracts ready for approval at the next board meeting.
- Brenden Wagner has been rehired and started March 14th.
- The new District truck, for use by the Neversink/Rondout program, has been ordered. It was ordered through the state bid and is slated to arrive in June.

B. District Policy:

• The Continuity of Government plan was reviewed. A simplified wording to show Continuity of Government will be added to the Personnel Policy.

C. No-Till Seeder Rates:

- Rental agreement was presented for approval. H. Russell made a motion to accept the rates and agreement based on a trial two-year learning period, G. Benson seconded the motion, the motion was passed and carried.
