- **II.** <u>MINUTES:</u> Beverly Martin made a motion to approve the minutes from the April 13, 2015 meeting, Harold Russell seconded, the motion was passed and carried.

- A. Neversink/Rondout Grant: See written report
 - Contract is being revised to change the insurance requirements.
 - 4 SMIP grants have been accepted for funding. Two reimbursements will go to Town of Denning for materials, dewatering for a streambank stabilization and a culvert to replace a metal bridge. Two to Town of Neversink for crane rental to place large rock for stream bank protection, and funding to conserve a 19th century land map of town.
 - The Two Year Action Plan was approved at the Watershed Advisory Group meeting.
 - Barton & LoGuidice are close to have the Hydrolic Model done for Claryville. MMI is doing the final survey and transferring data to B & L. A community meeting is set for July.
 - CSBI there are 2 large contracts for plant material. One for tublings for Greenbelt, and has been approved by DEP \$30,000. One for One Nature to grow the tublings. Their reduced price will be for \$210,512.

- Bob made a motion requesting the contract, when received, to be sent to County Attorney for review. If no changes then the contracts can be signed. Harold seconded the motion, the motion was passed and carried.
- B. No-Till Seeder:
 - Submitted a grant application to Sullivan County Dept. of Planning. Waiting for decision.
 - The price difference between the proposals was reviewed and discussed.
 - We will submit a grant application to the NYS Dept. of Ag & Markets.
